## TERMS AND CONDITIONS

Enrolment is subject to the following terms and conditions:

1. A \$500.00 deposit is required at time of application. This includes a \$150.00 non-refundable administration fee. If withdrawal from the camp session occurs on or before February 1, 2010, all amounts paid, other than the non-refundable \$150.00 administration fee, will be refunded. The full deposit is not refundable after this date. The balance of camp fees are due and payable before May 1, 2010, if deposit is paid by credit card, I authorize Kandalore Camp Co. Limited to charge the balance owing on May 1, 2010 to the card number on file. No refund of camp fees will be made under any circumstance after May 1, 2010.
2. A formal acceptance will be mailed to the parent or guardian to confirm enrolment.
3. If the camper has a potentially life threatening allergy or food sensitivity, we ask that the parent or guardian contact the Toronto office prior to completing and returning this form so that an allergy description form can be mailed to you. **Please note that Kandalore is not a peanut-free environment.**
4. There will be no reduction in or refund of camp fees for campers arriving late or leaving early in any period for which they are registered. There will be no reduction in or refund of camp fees for campers who are expelled from the camp for breaking camp rules or otherwise or are withdrawn from the camp prior to the end of the period for which they are registered.
5. Tuck shop, clothing purchases and medical charges will be charged as used.
6. Kandalore will not be responsible for any loss or theft of the campers' property.
7. Any deviation from the foregoing will be at the discretion of the Camp Director.

**Unless I advise you otherwise in advance in writing, I approve my child's participation in all of the camp's programs and activities, acknowledging that such participation involves risks and hazards incidental thereto, all of which are expressly assumed by me, and do hereby waive, release and absolve and agree to indemnify and save harmless Kandalore Camp Co. Limited and its officers, directors, employees and agents of any and all liability arising therefrom, except such as shall arise solely as a consequence of its or their wilful negligence or wilful default. If for any reason my child requires medical attention or special medication beyond that furnished by the camp, I agree to be responsible for any expenses incurred.
