CAMP TUITION

A deposit of \$500 is required to process the camper's application. A second payment of \$500 is due on or before January 31st. The balance is due on or before April 30th of the current camping year. *Accounts with balances that remain unpaid after January 31st or April 30th will forfeit all tuition discounts and may be cancelled at the discretion of the camp.* The camp tuition includes: lodging, board, laundry service (every week), camp nursing care, all program activities (except horseback riding in excess of 1 period a week, jet skiing, quad riding and paintball), camper reunion and camp newsletters. CANTEEN FUND CHARGE

The canteen fund is the only mandatory expense charged in addition to the camp tuition. The canteen fund covers: (1) the camper's snack bar allowance (2 items: 5+ days a week), (2) a camp t-shirt, (3) admission/travel to amusement parks, and (4) optional visiting day trips. The canteen charge is: \$400 for the full season, \$260 for the 1st 6 weeks, \$280 for the 2nd 6 weeks, \$200 for the first half session, \$140 for the middle half session, \$200 for the second half session, \$120 for the first 2 wk session, \$75 for the second, \$60 for the third and \$150 for the fourth 2 week session. Amusement Park Trips are scheduled July 2nd and August 12th.

BUS & BAGGAGE TRANSPORTATION CHARGE

Bus and baggage transportation is available 5 times during the camp season: (1) June 26th, (2) July 22nd, (3) July 23rd, (4) August 18th, (5) August 5th (only NY and NJ). Our bus transportation services the New York, New Jersey, Philadelphia and Baltimore areas on the dates 1-4. The bus and baggage service is an **optional expense**. The charge for this service is \$190 round trip or \$100 one way except the Baltimore stop. The Baltimore service is \$200 round trip or \$110 one way. There is a 1 duffel, 1 trunk limit. Special rates apply to airport pickups.

LINEN RENTAL (OPTIONAL)

The camp tuition includes the weekly laundering of the camper's clothes and linens. If the parent desires, the camp can supply blankets, sheets and pillowcases. The linen charge is \$110.00 for the full season, \$80, \$55 and \$30 for the 6 week, half season and 13-14 day session respectively.

TREATMENT AUTHORIZATION AND INSURANCE

Campers are required to carry medical insurance. Certain illnesses or injuries are referred to non-camp medical professionals whose fees are not covered by the camp tuition. If it is necessary, in the judgment of the camp director, to use outside medical, surgical or dental aid for the camper's health, *the parent(s) or legal guardian hereby authorizes him to obtain this medical care and further agrees to pay for the medical services provided whether or not the medical expense is covered by the parent's or legal guardian's insurance policy.*

REFUND OF TUITION PAYMENTS

Campers enrolling for their first summer at Lohikan who experience adjustment problems at camp and leave early are refunded the tuition for the days left early. Tuition refunds are based upon the actual session the camper attends camp. For instance, if a camper is enrolled for the full season and leaves camp at the end of the first-half session, the first-half session tuition is charged, not one-half of the full season tuition. The refund policy is designed to accommodate campers who experience adjustment problems at camp. It does not apply in other situations, i.e. vacation plans conflict with camp dates. Furthermore, violation of camp policies designed to promote adjustment (i.e., improper cell phone use) will void the guarantee. Enrollments cancelled before the camper's arrival in camp will be charged an admin fee of \$150.00. The balance in the camper's account will be refunded. The Canteen Fund is nonrefundable. Refunds are made after the camp season but before September 30, 2019. Camp Lohikan reserves the unrestricted right to dismiss, without a refund, any

any camper who exhibits emotional, psychological or behavioral conditions that are disruptive to the camp program or that are harmful to himself or the well being of other campers or staff.

CONDITIONS OF ENROLLMENT

Camp Lohikan strives to provide positive camp experiences for children with various needs whenever possible. However, Camp Lohikan does not provide programs that are rehabilitative or therapeutic in nature, and does not specialize in serving children with special needs, including children with severe emotional, social, or behavioral difficulties. Please provide information (attach a separate sheet) regarding your child's special needs, including any disabilities, disorders or medical problems with this application form. It is important to determine if the Camp Lohikan experience is appropriate for your child prior to attending camp. Failure to provide adequate information prior to your child attending camp may result in the camper being sent home without a refund. Lohikan cannot accept children who do not have the promise of living cooperatively with others.

◆ I understand and certify that my child's participation in Camp Lohikan and its activities (on or off-camp) is completely voluntary and I have familiarized myself with the camp's program and activities in which my child will be participating. I recognize that certain hazards and dangers are inherent in the Camp's programs particularly, but not limited to horseback riding, lake and pool swimming, water skiing, water sports, rock climbing, backpacking, hiking on mountain trails, cabin overnights, river canoe trips, circus arts, flying trapeze, gymnastics, tetherball, high and low ropes course, zip line, cycling on mountain trails and public roads, land sports, athletic competitions including bodily contact and contact with equipment and balls, inter camp games, lacrosse, baseball, archery, riflery, mt. boarding, skateboarding and inline skating, quads/dirt bikes, paintball, use of power tools and equipment in certain creative arts activities, and travel in camp-owned and/or leased vehicles. I acknowledge that, although Lohikan has taken safety measures to minimize the risk of injury to camp participants, the Camp cannot ensure nor guarantee that the participants, equipment, premises, and/or activities will be free of hazards, accidents or injuries. I hereby assume these risks and agree to hold harmless and hereby release, discharge and agree to indemnify Camp Lohikan, its directors, owners, agents and employees from all liability for loss, damage, injury or illness to the camper or camper's property related to his/her participation in the camp program. I have also instructed my child in the importance of knowing and abiding by the camp's rules, regulations (i.e. activity attendance) and procedures for the safety of camp participants, the requirement that campers attend scheduled activities and remain supervised at all times, and my child has agreed to do so.

- ◆ I understand that cell phones (and other devices capable of accessing the internet or photographing/videoing) are strictly prohibited in camp and will be confiscated (not returned) if brought to camp.
- ◆ Camp is not responsible for property lost or damaged by fire, theft or laundry.
- ◆ Photos/video/comments of my camper can be used for commercial purposes.
- ◆ A finance charge of 1.5% per month will be applied to all outstanding debts. Accounts which have not been paid within 60 days of billing will be subject to attorney fees (at least \$1500) and costs of the court and collection.
- ◆ It is agreed that the venue and place of trial of any dispute or cause of action arising between the parties, whether out of this agreement or otherwise, shall be the Court of Common Pleas in Wayne Cty., PA and shall be construed in accordance with the laws of PA. If the camp is successful in any litigation, it is agreed that the losing party will reimburse the camp for attorney fees & costs of litigation.
- ◆ The parent hereby states that the camper is in good, normal health and has no abnormal physical or mental handicaps unless otherwise indicated on the attached sheet. The parent hereby states that the camper is of sufficient maturity to properly care for his/her hygiene and participate in the camp's program.
- ◆ Lohikan is an English speaking camp. Campers must be conversant in English.
- ◆ Please note: Camp Lohikan is not a peanut or tree nut free camp.
