# Camper/Parent Agreement (must be signed by parents and understood by campers.)

It is important that all campers and parents have full understanding of, and be in agreement with the overall Cape Cod Sea Camps philosophy, ideals and goals related to group living and community involvement.

**I understand** Cape Cod Sea Camps program is an active, outdoor, group living experience of a positive and constructive nature. The program requires full and complete participation from all campers.

**I understand** that there are numerous risks associated with participation in any camping activities, including but not limited to activities such as sailing, swimming, archery, riflery, cycling, athletics, woodworking and transportation to and from camp activities. A complete listing of inherent and other risks is not possible and there may be some risks that cannot be anticipated. Risks that contribute to the unique character and desirability of the activities involved pose the possibility of severe injury, illness or death. I further understand that the activities involved will take place in an outdoor environment and upon open water where unalterable weather conditions may pose risks beyond the control of Cape Cod Sea Camps.

**I understand** Cape Cod Sea Camps reserves the right to determine whether or not a child is able to meet the physical and emotional rigors of camp life. The parent or guardian signing below understands that Cape Cod Sea Camps relies upon the information contained in this application form, medical information and other forms provided on behalf of the child. The parent or guardian below assumes all risk of loss arising from information that may not be accurate or complete and agrees to indemnify Cape Cod Sea Camps, its officers, directors, successors and assigns against all claims for loss, damage or injuries sustained to the child and relating to such incomplete or inaccurate information.

**I further understand that Cape Cod Sea Camps is not a therapeutic program or treatment center.**

**Further, it is understood by parents and campers and is agreed that:**

1. There shall be no smoking or use of smokeless tobacco products by campers at any time.
2. There shall be no drinking of alcoholic beverages by campers on the camp property or during any camp program away from the property.
3. There shall be no use of or involvement in marijuana, narcotics, or controlled substances or accompanying drug equipment.
4. Weapons and firearms are not permitted, with the sole exception of the camp's supervised instructional programs in archery and riflery, using equipment provided by camp.
5. Camp participants and their parents will read all materials sent and complete all forms in a timely manner required for participation at the Cape Cod Sea Camps.
6. Camp enrollment is for the entire session's term and no "deals" should be made between campers and parents for early departure from camp. Early departures are very disruptive to the cabin and unit groups and not in keeping with our overall goals for the camping experience.
7. Phone calls by campers during the first week of a session will be restricted. Cellular phone use by campers is not permitted on campus.
8. In the event of misconduct or other circumstances, Cape Cod Sea Camps reserves the right, in its sole discretion, to expel a camper before the completion of the session in which the camper is enrolled.

Unless otherwise stated, my signature permits camp to use photographs or video pictures of my child taken in the course of the program for publicity of camp or the American Camping Association. I also allow my child to share information via our website at [www.capecodseacamps.com](http://www.capecodseacamps.com) for camp purposes only.

*My child may use, under the supervision of camp staff, hazardous equipment involved in but not limited to activities such as Woodworking, Archery, Riflery, Cycling etc. My child may participate in any trip or activity sponsored and supervised by Cape Cod Sea Camps on or off the campus, and may travel when deemed necessary by the program via public carrier or vehicles operated by Cape Cod Sea Camps. I give permission for my child to participate in all camp activities including those described on the back of this form. I acknowledge and assume the risks involved in these activities and for any damage, illness, injury or death resulting from such risks for myself and my child. There are no physical, emotional, mental problems or limitations associated with my child's participation in camp activities, except as disclosed by me in writing to Cape Cod Sea Camps.*

In the event I cannot be reached in an emergency, I hereby give permission to the physician selected by the camp director to hospitalize, secure proper treatment for, and order injection, anesthesia, or surgery for my child named above. **I have read, discussed with my camper and understand and agree to the terms on both sides of the application including the Camper/Parent Agreement.**

**WAITING LISTS** Applications are accepted until space is filled in each of the Units. At that time a waiting list is started with names added as completed applications and the required deposit are received at the camp office. No names will be placed on the waiting list without a completed application on file. If we are unable to confirm a registration, we will refund the entire registration fee.

**PERSONAL EXPENDITURES OR CANTEN ACCOUNT** The pre-paid Canteen Deposit is a deposit towards expenses (Canteen account) incurred while at camp. Personal expenditures itemized on a Canteen account and not included in the tuition charge might be store charges, optional trips, travel arrangements to and from airports or by chaperoned buses or vans, special transportation, baggage handling, medical charges, Lost & Found returned articles, camper cash advances. Coupon books are issued to each camper and included in the tuition. Coupons are used in lieu of money for small purchases at the camp store, cabin treats, postage, etc. If your child charges clothing or other items rather than using their coupon books, this will also be posted to your account.

**PERSONAL PROPERTY** Cape Cod Sea Camps is not responsible for loss/damage of personal property due to fire, theft, laundry, and transit to and from camp, or carelessness of the camper.

**REGISTRATION FEE** A \$1000. **REGISTRATION FEE** (\$500. Non-Refundable) in **US FUNDS** must accompany the application with the understanding it is applicable toward the tuition. Prior to APRIL 1, \$500. of the Registration Fee is refundable.

**TUITION PAYMENT SCHEDULE** **February 1<sup>st</sup> Tuition Payment** – For those families who do not pay the tuition in full upon registration, a partial tuition payment, Canteen Deposit and JC Activity Fee are due. **April 1<sup>st</sup> Tuition Payment** - Final tuition payment is required to ensure enrollment at camp. **Failure to meet the April 1<sup>st</sup> tuition deadline may result in cancellation of enrollment at camp and forfeiture of any tuition discounts.** **No refunds are granted for cancellations after APRIL 1. No refunds or discounts are available for late arrival, absences, suspensions, dismissal, withdrawals or early departure.** Withdrawals after the start of the camp session at the request of the parent will forfeit the full camp fee.
